

# RULES FOR PARTICIPATION

(Please read the following conditions of participation carefully!)

## Details of the organiser:

The participant acknowledges that they may only participate in the safari at the address "Richter Safari Park", 2750 Nagykőrös, Szurdok dűlő 812, organised by the Organiser, subject to the following provisions.

The Organiser assumes no responsibility for the participant in case of any discrepancies with the information provided on the registration form.

## Conditions for participation:

The applicant guarantees that the data provided on the registration form corresponds in all respects to reality. The applicant consents to the Organiser being entitled to display and use photos taken during the organised safari for the promotion of its activities on its website and in its publications.

The applicant expressly consents, pursuant to Section 2:48(1) of the Civil Code, to the recording and publication of their face and appearance, specifying that their identity may only be disclosed with separate, explicit consent.

The applicant also acknowledges that the creator of the aforementioned recordings acquires unlimited, transferable, and exclusive rights of use in terms of space, time, and mode of use. The creator is entitled, without limitation, to utilise, use, reproduce, publish, adapt, disclose, transmit to the public, and distribute the recordings without any obligation to provide compensation to the visitor. In connection with the aforementioned recordings, the applicant expressly waives any claims or demands against the Organiser, as well as against the contractors involved in the organisation and execution of the safari.

The participant acknowledges that during the safari and on its premises, the Organiser shall not be held liable for any injuries, illnesses, accidents or financial damages that may occur.

The participant further acknowledges that throughout the duration of the safari and on its premises, they bear full financial and moral responsibility for any damages caused by them to the Organiser, any other participant of the safari, or any third party outside the safari, up to the total amount of damage.

The participant expressly acknowledges that the location of the safari, despite the utmost care and expected behaviour of the organisers, still poses the possibility of personal injuries and financial damages. The Organiser will make every effort to ensure the safety of the safari site with the highest degree of care and attention, but, due to the fact that wild animals are involved, the Organiser cannot be held responsible for any personal injuries or damage to the participant's own equipment, valuables, clothing or vehicle, and expressly excludes any liability. Everyone participates in the safari at their own risk, and the Organiser completely excludes all liability arising from participation.

The Organiser declares that the employees and staff working at the safari exercise due diligence in organising and conducting the safari. In light of the above information, the visitor participates in the safari at their own risk and uses the services of the Organiser at their own responsibility.

The participant acknowledges and agrees that they undertake the safari at their own risk, and therefore, the Organiser shall not be held liable for any injuries or damages that may occur during the safari. The participant is aware that the consent of the injured party excludes the unlawfulness of the damage.

Entry to the safari location is solely at one's own discretion and risk. Every participant, upon entering the safari area, accepts and acknowledges the provisions outlined in this regulation as binding for themselves. Not being aware of or lacking knowledge of the provisions of this regulation upon entry to the safari location does not exempt one from adhering to the regulations contained therein.
